GENERAL INFORMATION

1. Registration

PRE-REGISTRATION IS REQUIRED. PRE -REGISTRATION WILL BE BASED ON FIRST COME, FIRST SERVED AND NO PRE-REGISTRATION WILL BE ACCEPTED WITHOUT PAYMENT IN FULL AT THE TIME OF REGISTRATION. REGISTRATION MUST BE RECEIVED NO LATER THAN AUGUST 10, 2022

Entries after the deadline will be accepted only if space is available and are subject to a late registration fee of an additional \$50. On-site entries must be paid in cash only. There will be no registrations taken once the event has commenced

NOTE: ALL PARTICIPANTS MUST COMPLETE AND SIGN THE WAIVER FORMS AND SUBMIT AS PART OF THE REGISTRATION PACKAGE.

We encourage all participants to have received a full dose of approved vaccines against Covid-19 and encourage participants to wear protective masks while inside at the shooting venue. There will be no random Covid-19 tests administered to athletes. You can view the SFC's updated covid policy at the bottom of the program package.

2. Shooting Range

The 2022 Canadian International Trap Championships will take place at the Vancouver Gun Club in Richmond, BC

The Vancouver Gun Club has two outdoor international trap ranges for this competition as well as trap, skeet, and sporting clays ranges. Parking at the range is plentiful but please only park in designated area. All ranges are accessible for wheelchairs and mobility devices.

All reservations need to be made prior to the release date of July 29. Cancellations on room

already reserved will also need to be made at this time.

The hotel will cover transportation to and from the airport. For arrivals, guests need to keep the receipt and present it at the front desk at check in. For departures, the front desk will call the taxi and provide the taxi voucher.

The hotel is 5 minutes and 5 kilometers from the Vancouver Gun Club (VGC). There is a restaurant, Eggspectation, beside the hotel and many restaurants and fast food close by.

There are many other hotels available in the area but they are considerably more expensive.

4. Transportation

Athletes are responsible for arranging all of their own transportation to and from the Range and accommodation. Rental cars are available at Vancouver International Airport.

Since the cost of rental cars is quite high, we will try to provide a shuttle service for those competitors unable to rent a car from the Accent Inn to VGC in the morning and returning after shooting in the afternoon. If you want to participate in the shuttle service, please mention this in your pre-registration email.

5. Food

The VGC food service will be available generally on the weekend. Water and snacks will be available throughout the competition. Each morning orders will be taken for lunch (cash only) from a local restaurant. There are also restaurants close to the VGC offering a variety of food choices and all levels of dining experiences.

6. SFC Membership

All Canadian competitors **MUST** be current members in good standing of the Shooting Federation of Canada and be able to provide proof of membership. This will be verified by the SFC National Office prior to the match.

SFC membership is not required of Americans with current 2022 USA Shooting memberships. Non-Canadian participants must be a member of the ISSF Member Federation of the nation of their citizenship

Note: Non-Canadian participants must provide proof of liability insurance coverage or purchase an SFC membership with insurance included or local club may supply.

7. Rules and Regulations

The 2022 Canadian International Trap Championships will be conducted according to the ISSF Rules and Regulations, currently posted in the ISSF website at www.issf-sports.org. It is the responsibility of the athlete and coaches to be familiar with the current ISSF rules.

The Jury reserves the right to make exceptions to the Rules, procedures and times as and when necessary. All changes will be announced in writing and posted at the range. The Chief Referee will coordinate with the match director to select an appropriate number of jury members. Officials will hold a valid ISSF Shotgun A or B level referee or judge license.

All shooters are expected to serve as sideline referees or flankers. If scheduled for the next round, there will be at least a 20 minute break between flanking and shooting. If an athlete fails to act as a sideline referee when he/she is required to do so, they shall be penalized as per the ISSF Rules.

An up-to-date program schedule (with changes to time or added information) will be posted on site prior to the match.

Equipment control, if conducted, will be conducted according to the ISSF Rules and Regulation (9.4.1) using approved instruments.

Targets: The shooting range is equipped with International orange targets for qualification and flash targets for Finals.

Protests: Warnings/penalties will be given according to the current ISSF Official Statutes, Rules and Regulations. Protest forms will be available in the entry office.

Protests will be handled by the Jury. Cost is \$50.00 each. The Jury's decisions are **final**.

Finals: Semi Finals and Finals will be shot according to the current ISSF Rules and Regulations format. Only Canadian citizens will be eligible. Juniors may not be excluded from a Semi Final or Final in any event from which he/she has qualified.

Safety: All pertinent firearms safety practices will be observed. Failure to follow safety rules or direction from Officials or Jury may be cause for disqualification and/or removal.

Eye protection and ear protection is mandatory for all competitors and officials on ranges while shooting is in progress. Any medical emergencies should be immediately reported to a range official. Procedures will be posted

The Organizing Committee and the Shooting Federation of Canada will not be responsible for any articles lost or stolen or any article left at the range during the competition.

Dress Code: All competitors, officials, coaches, volunteers and any other parties involved in this event must adhere to the ISSF Dress Code policy.

Code Of Ethics: All competitors, officials, coaches, volunteers and any other parties involved in this event must adhere to the ISSF Code of Ethics policy. If this policy is violated in any way, please immediately make a formal report of such breach to the Match Director.

Behavior issues: Please be aware that the Organizing Committee will not tolerate any abuse of any kind of our volunteers, officials or competitors. If the Organizing Committee determines that such abuse has occurred or that the ISSF Code of Ethics has been breached, the Organizing

Committee will eject from the competition any individual responsible for such abuse. The individual may be ejected from any venue utilized by the Canadian International Trap Championships.

Non-medical use of drugs or the consumption of alcohol is not permitted anywhere on the VGC property during the competition.

ASSUMPTION OF RISK WAIVER

This waiver is only for the use of minor participants and/or spectators and should be completed and signed prior to any payment and/or registration or facility entry for this Event.

A “minor” (or “infant” or someone below the “age of majority”) is legally defined as anyone under the age of 19 in the Provinces/Territories of British Columbia, New Brunswick, Newfoundland and Labrador, Northwest Territories, Nova Scotia, Nunavut and the Yukon . Whereas in the Provinces of Alberta, Manitoba, Ontario, Prince Edward Island, Quebec and Saskatchewan, the age of majority is 18. COVID-19 Vaccination Policy – Event Attendance and Participation

1. POLICY

Shooting Federation of Canada (the “Organization”) is committed to taking every reasonable precaution in the circumstances for the protection of the health and safety of employees, athletes, and all stakeholders from the hazard of COVID-19. This Policy is intended to encourage, support and maximize COVID-19 Vaccination rates and safety at the Organization as one of the critical preventatives and control measures for the hazard of COVID-19. The Organization is also committed to compliance with all applicable public and occupational health and safety, human rights, privacy, and other laws in the development and implementation of this Policy. This policy outlines the minimum requirements the Organization requires for event attendance and participation. Further measures may be necessary per local, provincial, or federal covid guidelines.

2. SCOPE AND APPLICABILITY

This Policy applies to all attendees of events organized or hosted by the Organization, including but not limited to athletes, volunteers, and other participants. High Performance team members traveling to training camps, world cups and major games will be required to maintain their “vaccinated” status through 2023. Travel and attendance may be impacted, as requirements by the ISSF, world event organizers, host countries, airlines and the Federal government of Canada may change. Please keep aware of these shifting requirements.

3. DEFINITIONS

“COVID-19” is the infectious disease caused by SARS-CoV-2.

“Organization Activities” means all activities related to the Organization’s operations, whether conducted on or off Organization Premises, including events and travel.

“Organization Premises” includes, but is not restricted to, all land, property, structures, installations, vehicles or equipment owned, leased, rented, operated, used, or otherwise controlled by the Organization for the purpose of conducting Organization Activities. It does not include a Participant’s personal residence.

“Participants” includes all athletes, support staff, parents, guardians, volunteers and any attendees that attend Organization Activities.

“Proof of Vaccination” refers to government issued documentation demonstrating that an individual has been Vaccinated along with government issued photo identification that matches the individual.

“Vaccine(s)” refers to a vaccine approved by Health Canada for use in Canada in relation to COVID-19.

“Vaccination” refers to the administration of a Vaccine(s) to protect individuals from COVID-19. It may include the administration of one or more doses of Vaccine.

“Vaccinated” refers to an individual who has received all doses of a Vaccine, recommended or required by Health Canada, to produce an immune response to COVID-19.

4. VACCINATION

Health Canada, the federal and provincial governments, the Public Health Agency of Canada, regional public health authorities, the Canadian Medical Association have all endorsed voluntary COVID-19 Vaccination for all adults who may safely receive a Vaccine. The Organization strongly recommends that all Participants be Vaccinated at least 14-days prior to engaging in Organization Activities or entering the Organization Premises. The Organization reserves the right to COVID test any participant randomly chosen or who may be showing COVID signs. Those Participants testing Positive for COVID 19 by rapid test twice consecutively will be barred from participation at the event.

The Organization encourages individuals to continue to wear medical masks unless actively shooting, eating, or drinking, and are not permitted on the Organization’s Event Premises if they are demonstrating any COVID symptoms.

5. CONTINUED APPLICATION OF HEALTH AND SAFETY MEASURES

Nothing in this Policy relieves Participants, even those who are Vaccinated, from their obligation to comply with applicable health and safety measures required or recommended by the provincial and Federal public health authorities and related Organization policies in effect to reduce the spread of COVID19.

Furthermore, when travelling to other countries, Participants are required to follow the laws, recommended guidelines and protocols issued by local government, while out of country. At minimum, when Participants are travelling to other countries with the Organization, the Participants are required to comply with applicable health and safety measures required or recommended by Canadian and provincial public health authorities and related Organization policies in effect to reduce the spread of COVID-19.

6. PRIVACY

Regular Participants and Participants that Travel with the Organization

The Purposes of the Collection, Use and Disclosure of Vaccination Status Information

For regular Participants and Participants that travel with the Organization, Vaccination status may be collected, and may be used and disclosed pursuant to the terms of this Policy, the Shooting Federation of Canada’s Privacy Policy, the Personal Information Protection and Electronic Documents Act (“PIPEDA”) and other applicable provincial privacy legislation, where it exists. Vaccination status information will only be collected, used and disclosed as required for the reasonable purpose of:

- i. taking all reasonable precautions during the pandemic to ensure the health and safety of everyone in the Organization through appropriate health and safety planning based on Vaccination status;
- ii. limited disclosure, where necessary, to international federations or organizations running competitions or events or when determined to be necessary by the Organization; and
- iii. administering this Policy.

The Organization also reserves the right to disclose Vaccination status information to partners for the purposes of facilitating Organization Activities and will provide advance notice to the relevant Participant before so doing.

The collection, use or disclosure of this information will be based on the following terms:

1. Participants are to disclose their Vaccination status to the Organization on a proactive and ongoing basis or otherwise as directed in accordance with this Policy and may be asked to execute their written consent in the form appended as Schedule "A" to this Policy;
2. Participants who have completed a consent form will be asked to provide a copy of their certificate of Vaccination or other appropriate government issued alternative documentation so that the Organization can confirm their Vaccination status. Only the Vaccination status of the Participant will be recorded by the Organization; in the event an outside party requires athlete vaccination proof (ex. ISSF) for the Participant from the Organization, the Organization will notify the Participant in advance of providing this information.
3. The Organization will keep the Participants' Vaccination status confidential in accordance with PIPEDA and applicable privacy and health laws. Specifically, this information will only be shared and accessed on a need-to-know basis, solely for the purposes outlined above, or to comply with a legal order to disclose the information;
4. The information will be securely stored and maintained by the Organization in a separate file;
5. Participants will be able to access and rectify their personal information upon request, in accordance with applicable privacy laws; and
6. This information will only be retained for the duration of the Participant's relationship with the Organization and will be destroyed thereafter. Subject to official guidance on the outcome of the COVID-19 pandemic, it may be destroyed earlier, in which case a general notification will be communicated.

7. RESPONSIBILITIES

All levels of management of the Organization are responsible for the administration of this Policy in accordance with applicable law. Participants are responsible for compliance with this Policy, and shall comply with all applicable COVID-19 legal obligations in doing so, including with respect to public health measures such as physical distancing, wearing a mask, and staying home if they are sick.

8. AMENDMENTS

The Organization's Executive Committee will review this policy and update it as required and as reasonable in the evolving nature of the pandemic, Vaccine availability and government and public health authority direction.

9. REVIEW AND APPROVAL

This Policy has been reviewed and approved by the SFC Executive Committee on February 7, 2022.

10. REVISION HISTORY

This Policy was reviewed and amended July 8, 2022.

Schedule “A”

Express Consent Form for Regular Participants and Travelling Participants – COVID-19 Vaccination Information

This document is an express consent for the collection, use and disclosure of COVID-19 Vaccination status and will be required by participants that travel to some Organization events (training camps) and travel as part of the Organization’s team to international events.

By agreeing with this Consent, you are giving permission for the Organization to collect, use and disclose your personal information as described above for the following purposes:

- to take all reasonable precautions for the health and safety of employees, contractors, coaches, athletes, support staff, parents, guardians and volunteers in the Organization;
- to make decisions on athletic participation, particularly where Participants must directly interact with employees, contractors, coaches, athletes, support staff, parents, guardians, volunteers and others;
- to provide limited disclosure to international federations or organizations running competitions or events, or when reasonably required to facilitate the Organization’s Activities; and
- for administering the Organization’s COVID-19 Vaccination Policy – Event Attendance & Participation.

Personal information will be kept in a separate file and appropriate safeguards will be taken. It will be accessed only on a need-to-know basis, solely for the purposes outlined above, or to comply with a legal order to disclose the information.

Your information is being collected, used and disclosed pursuant to the Organization’s COVID19 Vaccination Policy and its Privacy Policy. The information will only be retained for the duration necessary.
