###### B.3. Maximum number of athletes per event:

The quota places are allocated to the NOC, except when quota places are achieved from the Qualification Ranking for the Olympic Games (QROG). NOCs can enter a maximum of two (2) athletes in each of the individual events, and a maximum of two (2) Mixed Teams in each of the Mixed Team events, comprising of the same athletes who have qualified and are eligible to compete in the individual events.



## C. ATHLETE ELIGIBILITY

### C.1. Compliance with the Olympic Charter and other relevant rules:

All athletes must respect and comply with the provisions of the Olympic Charter currently in force, including but not limited to Rule 41 (Nationality of Competitors) and Rule 43 (World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions).

Only those athletes who respect and comply with the Olympic Charter, the World Anti-Doping Code and the Olympic Movement Code on the Prevention of the Manipulation of Competitions, including the conditions of participation established by the IOC, plus the rules of the ISSF, may participate in the Olympic Games Paris 2024.

### C.2. Age requirements:

There is no age limit to be eligible to participate in the Olympic Games Paris 2024

### C.3. Additional eligibility criteria:

Athletes will also need to achieve the following in order to be eligible to participate in one (1) or more of the individual events at the Paris 2024 Olympic Games:

1. Be listed in the Qualification Ranking for the Olympic Games (QROG) ([https://www.issf-sports.org/getfile.aspx?mod=docf&pane=1&inst=474&file=ISSF-Ranking-system\\_2022.pdf](https://www.issf-sports.org/getfile.aspx?mod=docf&pane=1&inst=474&file=ISSF-Ranking-system_2022.pdf)) with at least one (1) ranking point achieved for each of the individual events they are to be entered for at the Paris 2024 Olympic Games.
2. Have participated at least in two (2) ISSF Championships during the Qualifying period for each of the individual events in which they are to be entered for at the Paris 2024 Olympic Games.

## D. QUALIFICATION PATHWAY

### D.1. QUOTA PLACES

#### Men/Women

Quota places can be obtained in the designated ISSF Championships that are conducted according to ISSF Rules ([https://www.issf-sports.org/theissf/rules\\_and\\_regulations.ashx](https://www.issf-sports.org/theissf/rules_and_regulations.ashx)) and take place between 14 August 2022 and 9 June 2024.

The table below specifies the number of quota places, per event, that are available at each of the designated ISSF Championships. The highest placed athletes will obtain one (1) quota place for his/her NOC, respecting the maximum number of athletes per NOC specified in section **B.2. Athletes Quota**.

**Special provisions:**

One (1) athlete can obtain only one (1) quota place for his/her NOC.

The quota places are allocated to the NOC, except when quota places are achieved from the Qualification Ranking for the Olympic Games (QROG). These quota places will be awarded to individual athletes and may not be changed by the NOC.

The final QROG list produced 9 June 2024 will be used to allocate one (1) quota place for each individual shooting event. Quota places will be awarded to the highest ranked athlete from the QROG having not yet already qualified in any event and also provided the NOC of the same athlete has not already achieved more than one (1) quota place in that event.

If at a designated ISSF Championship a quota place is achieved by an athlete who has already obtained a quota place at any previous designated ISSF Championship in any individual event, the quota place must be granted to the next highest placed athlete, in that event, in a designated ISSF Championship.

The same rule applies when the NOC of an athlete has already obtained the maximum number of quota places in that event.

One (1) NOC can obtain only one (1) quota place in any of the individual events at one (1) designated ISSF Championship.

All individual events consist of a Qualification stage and a Final stage. The Final stage is the part of the competitions held in a Finals Hall/Finals range with participation of top 8 (eight) athletes after Qualification stage and where the medal winners are decided. A quota place can only be obtained in the Final stage of any designated ISSF Championship.

An athlete with a quota place in one individual event may also get the right of participation in another individual event in case he/she meets the eligibility requirements described in section C. and the maximum number of athletes per NOC in this second event is respected. Such right is awarded to the individual athlete and not to the NOC.

**Mixed Teams:**

Mixed Teams in each of the Mixed Team events must be composed of the same athletes who have qualified and are eligible to compete in the individual events.



In case the number of Mixed Teams entered in a 10m Air Rifle/10m Air Pistol Mixed Team events exceeds the available number of firing points for one (1) Qualification relay, the QROG will be used to determine the final entry list. The combined number of points according to the QROG in the respective individual events of 10m AR or 10m AP produced 9 June 2024 of both members of the Mixed Team will be taken in consideration.

If still a tie, the priority will be given to the Mixed Team with an athlete (male or female) who has the highest number of points according to the QROG produced 9 June 2024 in the individual event of the respective Mixed Team event.

The maximum number of Mixed Teams in Skeet Mixed Team event is eighteen (18).

In case the number of Mixed Teams entered in Skeet Mixed Team event exceeds eighteen (18), the QROG will be used to determine the final entry list. The combined number of points according to the QROG in Skeet individual events (produced 9 June 2024) of both members of the Mixed Team will be taken in consideration.

If still a tie, the priority will be given to the Mixed Team with an athlete (male or female) who has the highest number of points according to the QROG (produced 9 June 2024) in Skeet individual event.

## D.2. HOST COUNTRY PLACES

The host country will automatically qualify one (1) male and one (1) female athlete in each individual event on the condition that the athletes meet the eligibility requirements described under section C of this document

Host country places will only be granted in an event if host country athletes did not obtain a quota place in that event during the qualification period.

## D.3. UNIVERSALITY PLACES

Sixteen (16) Universality places (8 per gender) are made available to eligible NOCs at the Olympic Games Paris 2024.

On 1 October 2023, the International Olympic Committee (IOC) will invite all eligible NOCs to submit their requests for Universality places. The deadline for NOCs to submit their requests is 15 January 2024. The Tripartite Commission will confirm, in writing, the allocation of Universality places to the relevant NOCs after the end of the qualification period for the sport concerned.

Detailed information on Universality places is contained in the “Games of the XXXIII Olympiad, Paris 2024 - Olympic Games Universality Places - Allocation Procedure and Regulations” document.



## E. CONFIRMATION PROCESS FOR QUOTA PLACES

### E.1. CONFIRMATION OF QUOTA PLACES

Olympic Qualification Tracker

The ISSF Olympic Qualification Tracker (OQT) will specify the number of quota places per event that each NOC has obtained during the entire qualifying period. The final ISSF OQT will be submitted to all NOCs and all ISSF Member Federations within 5 days after the end of the Qualifying Period, but not later than 14 June 2024.

The ISSF will also publish on its website (<https://www.issf-sports.org>) the current status of the QROG in each of the 12 individual Olympic events.

The ISSF will email the respective NOC a letter informing the NOC of an athlete's eligibility to receive a QROG individual quota place within 5 days after the end of the qualifying period, but no later than 14 June 2024.

The NOCs will have one (1) week to confirm if they wish to use these quota places to enter qualified athletes in the Olympic Games Paris 2024 but must do it not later than 21 June 2024 as detailed in section **G. Qualification Timeline**.

If an NOC enters in any event in which that NOC has also obtained the maximum number of two (2) quota places an athlete who has a quota place in one individual Rifle or Pistol event and a possibility to take part in the second individual Rifle or Pistol event according to the QROG, the unused quota place must be returned to the ISSF for reallocation.

An NOC may request to change a maximum of one (1) quota place in one (1) event for one (1) quota place in another event within the same gender if available and if the NOC does not have the maximum number of quota places for that event, with the exception of the quota places obtained via the QROG. Applications for quota place changes must be received by the ISSF not later than 21 June 2024.

### E.2. CONFIRMATION OF HOST COUNTRY PLACES

The host country must confirm in writing by email to the ISSF the use of its host country places as detailed in section **G. Qualification Timeline**.



## F. REALLOCATION OF UNUSED QUOTA PLACES

### F.1. REALLOCATION OF UNUSED QUOTA PLACES

Each quota place allocated at the Continental Championships and/or Games, that is not confirmed by the NOC, by 21 June 2024, or are declined will be reallocated to the next highest-ranked eligible athlete according to the QROG, with the NOC of the respective continent having not already qualified a quota place or Universality place, in the event at which, the quota place was achieved.

If, within the respective continent, an NOC cannot be found to reallocate a quota place from the results of the Continental Championships/Continental Games, then the quota place will be allocated to the next highest ranked eligible athlete from the QROG in the event in which a quota place was achieved, not yet already qualified irrespective of the continent and not exceeding the NOC maximum quota per event.

Each quota place allocated at the ISSF World Championships, that is not confirmed by the NOC by 21 June 2024, or is declined, will be reallocated to the next highest-ranked eligible athlete according to the QROG in the event at which the quota place was achieved, according to the criteria outlined in sections C and D.

If a QROG quota place is declined or not confirmed by the NOC or if there is an unused QROG quota place, that quota place will be reallocated to the next highest-ranked eligible athlete according to the QROG, not yet qualified, in the same event at which the quota place was allocated.

If there is still a tie, according to the QROG rankings, the priority will have the athlete who represents the NOC that does not have any quota place or a Universality place in the event at which the quota place was allocated.

### F.2. REALLOCATION OF UNUSED HOST COUNTRY PLACES

Unused host country place(s) will be reallocated to the next highest-ranked eligible athlete according to the QROG, not yet qualified, in the event at which the host country place was granted respecting the maximum quota per gender and per NOC in that event.

### F.3. REALLOCATION OF UNUSED UNIVERSALITY PLACES

Any unused Universality place(s) will be reallocated to the highest-ranked eligible athlete of the same gender not yet qualified, from the NOC that does not have any quota place or a Universality place in the event at which the Universality place was allocated.



## G. QUALIFICATION TIMELINE

The qualifying period for shooting is from 14 August 2022 till 9 June 2024. During this period the QROG points and quota places can be obtained.
